Each year, the number of inquiries was received has stayed the same or increased. In 2013, we handled approximately 65 inquiries as compared to 2012 (50 individuals and/or families). Our number of clients served also increased by 50 by year's end, compared to 43 in 2012. At the end of 2013, Push To Walk's staff included 4 full time trainers, 4 part time trainers, 4 aides and 2 full time administrative staff people. College student interns are utilized for administrative projects whenever possible, and in 2013, 2 interns worked at Push To Walk in the video recording/production areas.
