In 2017, Push to Walk served a total of approximately 72 clients, which was comparable to the number of clients served in 2016. Inquiries were up significantly in 2017 compared to 2016 with the move to a new location in October 2016 that provided more foot traffic to building tenants and increased interest in the services provided. Push To Walk continued to average approximately 450 service hours per month. At the end of 2017 our program staff included 5 full-time trainers, 2 part-time trainers and 6 part-time aides. Administrative staff consisted of an Executive Director (10 months for 2017), an Operations Director, a part time Development

2017 started off with a new Executive Director (ED), having just moved to our new location in October 2016. The move proved to be very beneficial in many ways. First, being located in a building with a Physical Therapy office and gym offered "foot traffic" that we did not previously have. Second, we not only moved to a new town but a new county as well. This gave us the opportunity to introduce ourselves to our new communities, raising awareness, making new connections and gaining new clients. Third, the layout of our new space with larger room for the gym program and equipment helped us improve the program offerings to our clients.
