In 2024, Push to Walk served 106 different clients for a total of 6,643 client hours of service: 6,306 one-on-one workouts, 51 initial evaluations (a large increase from 2023), 154 sessions with FES stimulation, 12 Exoskeleton Robotics Evaluations and 47 Exoskeleton Sessions (new this year), and 18 PoNS sessions (Portable Neuromodulation Stimulator for specific stimulation of the brain).
Staffing included 9 trainers and 10 aides/student interns over the course of the year. Administrative staff included a part-time Executive Director, a full-time Operations Director, a part-time Development

In 2024, grants from corporate and private foundations were received to assist with operational costs and fund specific needs like continuing education, equipment and scholarship funds for clients. Equipment manufacturers provided specific training on certain devices, leading to higher and better use with clients.
A client/staff joint event - Race a Thon - was held at Push to Walk in October and allowed clients to participate by walking/pushing for various distances, enabling them to raise funds for their workouts at Push to Walk. About 10 people in total took part in the event. Client scholarships were provided to those clients with financial
